Electricity tariffs unchanged for 2014 - innovative locally

focused price-plan coming soon

Romande Energie has announced that its electricity tariffs for 2014 will be unchanged relative to this year. In addition, a new price-plan in favour of local procurement will soon be unveiled. Next year customers will benefit from our longstanding efforts to keep expenses in check and improve efficiency across the regional power network - in contrast to forecasts by the Federation of Swiss Power Companies of an upward trend in nationwide electricity rates.

We are delighted to announce that our electricity tariffs in 2014 will be unchanged relative to those currently charged, especially since the Federation of Swiss Power Companies has announced — in a press release on 27 August — that it expects an upward trend in Swiss tariffs next year. The new pricing schedule, which is being published today, enters into force on 1 January 2014.

Electricity tariffs are determined by several components: the cost of the power itself, use of the regional power network, use of the national VHV transmission grid, the cost of regulating power (system services), and taxes and duties.

Efficient regional network keeps rates unchanged

For yet another year we have stepped up efforts to inject efficiency into our running of the regional power network. Improved operating procedures and the new asset-management policy (governing investments in distribution infrastructure) will, for the fourth successive year, result in a reduction in this tariff component.

The lower regional network cost will benefit our customers directly, offsetting the rise in tariff components outside our control, namely: the increase in the price of regulating power (system services) charged by national grid operator Swissgrid SA; changes to the rate of interest earned on capital invested in power networks; and the rise in federal duty (from 0.45 ct to 0.60 ct per kWh) for financing compensatory feed-in remuneration — under the system introduced by the Confederation for promoting generation from renewable sources.

Details of new price plan coming soon

We are putting the finishing touches to a new price plan that we believe is in tune with our customers' hopes and expectations. Details will be unveiled in October. Tariffs published today are unaffected by this development.

The price of electricity is comprised of the following:

- Cost of power
- Network charges
- Taxes and duties charged by the Confederation, cantons and municipalities.

Network charges represent the cost for moving power from its point of generation to the ultimate point of consumption in addition to costs for regulating the system. There are three components:

- Regional grid usage fee, within the remit of Romande Energie
- Transmission fee for use of the VHV national grid, within the remit of Swissgrid SA
- Regulating power (system services), which also comes under Swissgrid SA

Price components that depend directly on Romande Energie (power and grid usage fee) account for slightly over 80% of the average consumer's electricity bill.

The remaining 20% - the transmission fee, regulating power, and taxes and duties - is collected by Romande Energie and passed along, as appropriate, to Swissgrid SA or to Confederation, cantons and municipalities.
