## Joint effort to accelerate the energy transition

Four partners based in Western Switzerland working together to add hydrogen to the property sector's energy mix. Green hydrogen produced and stored locally thanks to a flexible, decentralised supply chain to provide a valuable addition to the renewable energies required for the energy transition.

The Nomads Foundation is today unveiling Aurora, a large-scale project also involving GreenGT SA, Romande Energie SA and Realstone Group. The goal of this partnership is to develop solutions using locally produced hydrogen as an energy source for the property sector. The Nomads Foundation will also conduct advance planning within the training sector to encourage the emergence of the skillsets required by the construction industry in the future.

This partnership, driven by the vision that hydrogen molecules can further increase the efficiency of renewable energies, will pave the way for the addition of integrated solutions – such as water electrolysis and fuel cells – to existing systems such as solar photovoltaic and storage battery technologies. Harnessing this combination will help to meet demand for heating and electricity.

Aurora is a multi-year project that initially aims to model, install the system in a set of buildings and ultimately market green-hydrogen solutions. The implementation phase could potentially be supported further out by public infrastructure and regional development institutions.

Aurora includes various innovations in hydrogen production, distribution and utilisation. By joining forces, the partners want to explore the applicability of different technological solutions as a way of addressing the climate emergency and decarbonising (or decarbonating) the property sector. Effectively working together within a foundation that foresees the new specialisations stemming from the energy transition, they possess the complementary engineering, energy and property-related skills crucial for the project's success. Together, they aspire to create a prototype building that will serve as a blueprint for incorporating hydrogen in the property sector's energy mix.
