Partnership to help companies in Western Switzerland go net zero

In the corporate world, accurately measuring greenhouse gases and taking concrete steps towards mitigation is a challenge, first because the whole company must be on board and secondly because the theory, however virtuous, must be translated into realistic, effective actions. To overcome these hurdles, Romande Energie and dss+ have teamed up to create ZenCO₂. What makes this service unique is that it not only helps define net zero strategies but also advises and assists companies in how to implement net zero at an operational level.

Romande Energie has set its sights on making Western Switzerland the first net zero region in the country, even as we face an unprecedented energy crisis. To do this, the company is teaming up with dss+ (formerly Sofies), a Geneva-based advisory firm focusing on operating risks and sustainable development, to create ZenCO₂ (= **Zero net CO₂**) – a range of services to help companies transition to clean energy using roadmaps for cutting greenhouse gases.

ZenCO₂ will support companies in Western Switzerland with a full and flexible range of services, from advice for sustainably reducing greenhouse gas emissions (diagnostics/carbon footprint quantification) and establishing tangible emission targets to zero-carbon planning, goal-setting, guidance during the transformation and on-the-ground management of multi-technical projects. Romande Energie and dss+ will provide the right tools, methods and tried-and-tested solutions for meeting these targets.

The whole purpose of this service is to help companies in Western Switzerland take concrete steps towards cutting their carbon emissions, and, as a result, make their business models more ‘future proof’. Amid the current energy crisis, cutting greenhouse gas emissions in many cases means improving efficiency and streamlining usage, leading to lower energy consumption.
