Romande Energie expands its renewable energy base in France

Romande Energie France and Calycé Développement have signed a codevelopment partnership covering a portfolio of 15 wind farm projects in France, located in the Grand Est, Hauts de France and Pays de la Loire regions and representing a total output of 646 MW. This acquisition drives forward Romande Energie's plans to speed up the clean energy transition.

Under the terms of the partnership, Romande Energie will acquire interests in six early-stage projects (50% shareholding), seven late-stage projects (100%), a guaranteed project (80%) and a wind farm that is already in operation (100%).

Calycé's team will continue to manage all projects until they are ready to be built.

Expanding base of renewable assets

Since 2013, the Romande Energie Group has acquired a series of hydro-, solar- and windpower assets in France as it seeks to complement its hydropower portfolio in Western Switzerland, diversifying its exposure in terms of both technology and location. This alliance fits its strategy perfectly.

This latest acquisition will represent a significant stride forward for its network of renewable assets in France.

The transaction will be closed in the coming weeks, once the conditions precedent under the terms of the sales and purchase agreements have been satisfied. At that point, a detailed press release will be issued.
